Maximum transaction fee capped at 150 EUR for Standard D+2; 175 EUR for Urgent D+1; 195 EUR for Express D.
- (4) This service charge is an extra fee for large transactions to check documents and scan KYC compliance. The processing fee is still fixed following the information on the above table.
